Terms & Conditions Policy

Eligibility Criteria



UPDATED 02.06.2023

The Victorian Teachers' Games (VTG), is organised by School Sport Victoria, as part of the Department of Education (the department).

These terms and conditions apply to all events conducted by the VTG, taking place in Latrobe City from Sunday 17 September to Wednesday 20 September 2023.

Please carefully read the information below before you confirm your registration for VTG in 2023. If you have any questions or concerns please contact the <u>VTG</u>.

RATIONALE

The aim of this policy is to define the terms of conditions and eligibility criteria for registration and participation at the Victorian Teachers' Games (VTG).

Eligibility is subject to participants' agreeing to comply with related VTG policies, which is part of the registration process. Individuals, or teams with individuals, identified as being ineligible for whatever reason, will be disqualified and removed from the event.

TERMS AND CONDITIONS OF ENTRY

I acknowledge and agree I have read and understood the following terms and conditions of entry and agree to be bound by these terms of entry. If another person has entered me in the event, that person is assumed to be my agent and that person has accepted on my behalf all the terms and conditions set out on the online registration system:

- 1. The information provided by me on this registration entry form is true and accurate in all respects.
- 2. I am in good physical condition and health, enabling my safe participation in the events I have entered and accept I participate in any officially sanctioned VTG event at my own risk.
- 3. I acknowledge by entering in the VTG, the activities I enter may require me to be fully vaccinated against COVID-19 (or have a valid exemption) in order to take part.
- 4. I agree to the payment of relevant registration and individual event fees as required for participation at VTG, as outlined and agree that I submit my registration with knowledge and acceptance of the non-refundable registration fee.
- 5. I acknowledge I have read in full, understand and meet the VTG Participant Eligibility criteria.
- 6. I agree to abide by the VTG Rules & Regulations governing the delivery of the event and understand event cancellation protocols.
- 7. I acknowledge I have read in full, understand and accept the VTG Behaviour Policy.
- 8. I acknowledge I have read in full, understand and accept the VTG Refund Policy, and thus acknowledge I am only eligible for a refund in exceptional circumstances as stated in the Policy.











- 9. I acknowledge failure to comply with the policies stated in (4), (5), (6) and (7) may result in my removal and disqualification from any and/or all VTG organised activities and may also result in further action by the VTG organising committee.
- 10. I consent to the release of my personal information to the department to allow VTG to best carry out its function in operating the event(s), including relevant direct communication.
- 11. I accept and acknowledge due to venue and other restrictions (including but not limited to restrictions implemented by the Victorian government arising out of the COVID-19 pandemic), the number of participants may be limited and reach capacity in some events. Should my entry into an event not be accepted due to insufficient places being available, I understand I am entitled to select another event.
- 12. If I am suspended or banned by a recognised sporting body, I will advise VTG as soon as practicable before the event commences and this may result in VTG removing my entry to the event on this basis.
- 13. I acknowledge VTG does not have personal accident insurance and I participate in the events at my own risk.
- 15. I agree to receive any medical treatment, including ambulance transportation, which VTG first aid staff or medical practitioners reasonably consider necessary or desirable for me during my participation in the event due to injury, accident and/or illness.
- 16. I agree I am liable for all associated medical costs outside of those provided by VTG first aid staff (e.g. ambulance, further medical appointments).
- 17. I acknowledge event organisers are not responsible or held accountable in the instance of event cancellation for any other fees incurred for my planned participation at VTG, including (but not limited to) accommodation, uniforms and transport.

VTG PARTICIPANT CRITERIA

To be eligible to attend the Victorian Teachers' Games, participants <u>must</u> fall under one or more the following categories: -

- 1.A current teacher within any Victorian school (government or non-government)
- 2.All staff employed by the Department of Education, Victorian school or relevant School Council including classroom and non-classroom support staff. This excludes School Council members and preservice teachers.
- 3. A current holder of a valid Victorian Institute of Teaching registration (including current casual relief teachers throughout Victoria)
- 4. A current Corporate employee of the department. Non-government education institutions are also included.
 - a. As per the current Victorian Public Service Enterprise Agreement 2020, leave with pay up to a maximum of two weeks in any two calendar year period may be granted to an Employee to participate either as a competitor or an official in any non-professional state, national or international sporting event. This applies to department Corporate staff when attending VTG.
- 5.A retired teacher of the workforce
- 6. Registered VTG volunteers
- 7. Official sponsor staff

Proof of any category above will be required when registering for VTG.
